ACTIONS FOR ALLOTMENTS:

1. EPC vs Ellisfield Allotment Trustees. Peter confirmed that the EPC as a single body is correct on the Charity Commission website (as opposed to Councillors). However, as Trustees we have difference R&Rs so need to have separate meetings (as we have at present) and ensure we don't discuss allotment items on the EPC agenda

ACTION: Elect a Chairperson and Secretary for the Ellisfield Allotment Trustees. Would suggest Richard and Hannah although it can be different e.g. Lucinda could be the Chairperson. TRUSTEES to raise propose at Allotments meeting. Set up separate Allotment meetings maybe 3 times a year – best aligned with the EPC meetings

<u>Dec 2023 Update</u>. This has been actioned. Agreed that Lucinda will take the role as Chair and the EPC clerk will take the role as Secretary (operating as separate roles)

2. Amend EPC assets register to show correct status of the Allotments ACTION: Allotments to be registered on the EPC register but with a note stating that they come under the Ellisfield Allotments charity. EPC CLERK <u>Dec 2023 Update.</u> This has been actioned. New Asset register uploaded to the website and on the agenda for approval by Councillors at the next Parish Council meeting. Allotment assets are highlighted as separate since they belong to the Ellisfield Allotment Charity Commission

3. Remove policies from Charity Commission website which have no minuted approval by the trustees.

ACTION: There are unknown documents on the website for Complaints handling, Risk Management and Volunteer Management. No one is sure where they come from but need to be removed and replaced with the ones Hannah has drawn up. TRUSTEES SECRETARY

Dec 2023 Update. The process is in progress

4. Action taken to inform the auditor that last two AGAR forms are inaccurate as a result of omitting to

disclose that the body corporate (i.e., EPC) acts as sole trustee.

ACTION: See attachment – point 11b. The AGAR needs to state that the EPC submission does not include Trust Transactions for the past years. It's set to N/A but should be Yes. May be check with our Auditor to see if we need to change it retrospectively. EPC CLERK

<u>Dec 2023 Update.</u> Checked with Auditor, no remedial action to be taken for current and previous years but will be set to the correct status going forward

5. Consider registering the land. It is recommended as good practice for charity trustees to register title to their property voluntarily in any event. Registration carries with it a State guarantee of ownership, boundaries and rights over property can be clarified, there is significantly more protection against squatters' claims and additional measures can be taken to be alerted to potential property fraud.

ACTION: Recommend registering land unless there is good reason not to. <u>TRUSTEES SECRETARY</u>

<u>Dec 2023 Update</u>. Agreed this is a good idea in principle, however, the trust deed for the land is held at the National archive office in Kew. Clerk would need to visit in person to obtain the document. Plan to action in 2024.

6. Funding. EPC can provide funding to the Ellisifield Allotments. This should be budgeted via Grants and Donations by the EPC

ACTION: Already included as a line item in the EPC budget. For 2024/2025 it is zero. EPC CLERK

Dec 2023 Update. No action required for the coming year

7. Resend invoices to allotment holders this time from 'Trustees of Ellisfield Allotments' and not from EPC.
