MAIN FLOOD DEFENCES - Annually (to avoid houses being flooded:

- Lower Common, Furzen lane and bottom of green lane (new defences to avoid Berry down lane, Axford and Preston Candover flooding). £1000

- Bell Lane dip and Kit lane house £400

OTHER DRAINAGE ACTIVITIES to maintain grips, condition of roads and appearance of village – work rotated on a 3 year cycle – up to a cost of £1050

- Church lane buy Village Hall
- College lane lower part grips etc
- Top section of college lane
- Top of Furzen Lane
- Gravel Pits
- Lower part of green lane grips

- Other activities in place of the above that may arise according to weather conditions
